

Our Cookies Policy

1. WHAT ARE COOKIES?

Cookies are files that websites or applications install on the user's browser or device (smartphone, tablet, etc.) during their journey through the pages of the site and serve to store information about their visit. In general, these technologies can serve a variety of purposes, such as, for example, recognizing you as a user, customizing the way content is displayed or learning how you use our website. Cookies can only be read by the server that placed them and cannot run any programs or viruses.

2. WHAT TYPE OF COOKIES ARE USED ON THIS WEBSITE?

Regarding the purpose of cookies, we use the following cookies on this website:

- **Strictly Necessary Cookies:** These are essential for websites to provide simple functions or to access particular features.
- **Functional cookies:** These cookies are mostly used to enhance the performance of a website as without them certain functions may not be available. In addition, they allow to remember user preferences and settings.
- **Performance cookies:** These cookies allow the party responsible for them to monitor and analyze the behavior of the users of the websites to which they are linked. The information collected through this type of cookies is used to measure the activity of the websites, application or platform and for the elaboration of browsing profiles of the users of these sites, applications and platforms, in order to introduce improvements based on the analysis of the usage data of the users of the service.
- **Targeting cookies:** These cookies track users' actions and are used to identify users between different websites. Targeting cookies collect user information and use it to build a profile of users' interests and then show personalized ads for that specific user.

Likewise, regarding the entity that manages cookies, this website uses the following:

- **First-party cookies:** These are those that are sent to the user's terminal equipment from a computer or domain managed by the editor itself and from which the service requested by the user is provided.

This website manages under its domain strictly necessary cookies.

- **Third-party cookies:** Likewise, this website uses third-party cookies understood as those that are sent to the user's terminal from a computer or domain that is not managed by the editor but by another entity that processes the data obtained through the cookies.

Regarding the period of time that they remain activated, we use the following on this website:

- **Session cookies:** These are those designed to collect and store data while the user accesses a web page and disappear when the browser is closed.
- **Persistent cookies:** are those in which the data are still stored in the terminal and can be accessed for a period defined by the person responsible for the cookie that can range from several minutes to several years.
